Member Highlight - Dorothy Buechner, Education Committee Chair & Chapter Past President

I have been with American Family for 22 years, with the past 17 years in Education and Human Resources working with the company's professional development programs. Through my own studies and my work with our professional development programs, I developed a passion for helping others to learn about the industry.

I've been involved with the Dairyland CPCU Chapter since earning my designation in 1999. I have served in each of the chapter officer positions and am currently the Co-Chair for the chapter's Education Committee.

The mission of the Education Committee is to provide opportunities for insurance professionals to increase their industry knowledge. The main offerings to date have been instructor-led classes for preparation for the national exams for The Institutes' designation programs (i.e. CPCU, AIC, AINS, etc). Since the fall of 2011, we have offered 20 classes (11 CPCU, 1 AIC, & 8 AINS) that helped 161 students from 9 different companies prepare for their exams. We are looking to expand our offerings to include technical workshops that are filed for state CE credits.

The classes are offered twice a year (spring and fall) and meet once a week in the evening at a Madisonarea location. We are offering the following classes this fall: AINS 21, AINS 23, CPCU 500, CPCU 530 and CPCU 540. We will begin planning for our spring 2015 classes in early October. A communication regarding registration will be going out in early January.
